Please read carefully:</p> <p>I have read the Equine Canada/USEF Entry Agreement (Article 1502.5) as printed in the Prize List for this Competition and agree to all of its provisions.</p> <p>I AGREE to waive the right to the use of my photos & videos from the competition.</p> <p>I AGREE in consideration for my participation in this Competition to the following:</p> <p>I AGREE that I choose to participate voluntarily in the Competition with my horse, as a rider, driver, handler, lessee, owner, agent, coach, trainer, or as parent or guardian of a Junior Exhibitor. I am fully aware and acknowledge that horse sports and the Competition involve inherent dangerous risks of accident, loss, and serious bodily injury including broken bones, head injuries, trauma, pain, suffering, or death ("Harm").</p> <p>I AGREE to release Equine Canada/USEF and the competition from all claims for money damage or otherwise for any Harm to me or my horse and for any to others, even if the Harm resulted, directly or indirectly, from the negligence of the Equine Canada/USEF or the Competition.</p> <p>I AGREE to expressly assume all risks of Harm to me or my horse, including Harm resulting from the negligence of Equine Canada/USEF or the Competition.</p> <p>I AGREE to indemnify (that is, to pay any losses, damages, or costs incurred by) the Equine Canada/USEF and the Competition and to hold them harmless with respect to claims for Harm to me or my horse, and for claims made by others for any Harm caused by me or my horse at the competition.
