Please read carefully:</b></p> <p>I have read the Equine Canada/USEF Entry Agreement (Article 1502.5) as printed in the Prize List for this Competition and agree to all of its provisions.</p> <p><b>I AGREE</b> to waive the right to the use of my photos &amp; videos from the competition.</p> <p><b>I AGREE</b> in consideration for my participation in this Competition to the following:</p> <p><b>I AGREE</b> that I choose to participate voluntarily in the Competition with my horse, as a rider, driver, handler, lessee, owner, agent, coach, trainer, or as parent or guardian of a Junior Exhibitor.
