Training equipment, informal riding attire is permitted. No Draw Reins. Approved Helmets are required at all times when mounted at

Stabling / Haul in Fees

Stalls are available for a cost of \$ 70.00 for the clinic including bedding. Stalls will be assigned and may be occupied after 12 noon on each Friday before the clinic. A Clean out deposit of \$ 25.00 must be included for all assigned stalls in separate check with entry form. Haul in Fees must be paid for all horses not stabled on grounds for a cost of \$ 25.00 for EACH day on grounds and park in assigned Haul In Parking area ONLY. Stalls will be assigned at the sole discretion of clinic manager. Stalls must be stripped clean before 6pm Sunday or the Clean out deposit check will be processed.

Assigned Horse Numbers

Assigned Entry Numbers must be worn at all times outside stall while on grounds on all days of clinic. Entry Numbers must be picked up at show office on arrival and prior to removing horses from stalls.

Schooling Horses

Schooling Horses are permitted to attend competition grounds for schooling purposes for a fee of \$ 25.00 per day. An Entry Form must be completed and number assigned for all schooling horses by the Entry Closing Date. Stabling charges and or Haul In fees are applicable for all schooling horses in addition to day fee. All fees including the \$30.00 administration fee must be paid on Entry Form for schooling horses. Indoor arena will be available at specified times for schooling horses to school indoors in dressage arena.

ENTRY AGREEMENT

Assumption of Risk, Waiver and Indemnification.

This document waives important legal rights. Read it carefully before signing.

I AGREE in consideration for my participation in this Event; " Gateway Dressage Schooling Clinic" to the following:

I AGREE that I choose to participate voluntarily in the Clinic with my horse, as a rider, driver, handler, lessee, owner, agent, coach, trainer, or as parent or guardian of a junior exhibitor. I am fully aware and acknowledge that horse sports and the Thunderbird Show Park Clinic involve inherent dangerous risks of accident, loss, and serious bodily injury including broken bones, head injuries, trauma, pain, suffering, or death ("Harm").

I AGREE to release Thunderbird Show Park from all claims for money damages or otherwise for any Harm to me or my horse and for any Harm caused by me or my horse to others, even if the Harm resulted, directly or indirectly, from the negligence of Thunderbird Show Park.

I AGREE to expressly assume all risks of Harm to me or my horse, including Harm resulting from the negligence of the Thunderbird Show Park, officials, officers, directors, employees, agents, personnel, volunteers, or any other affiliate organization or participant of the show.

I AGREE to indemnify (that is, to pay any losses, damages, or costs incurred by Thunderbird Show Park and to hold them harmless with respect to claims for Harm to me or my horse, and for claims made by others for any Harm caused by me or my horse at the Thunderbird Show Park Dressage Clinic.

If I am a parent or guardian of a junior exhibitor, I consent to the child's participation and AGREE to all of the above provisions and AGREE to assume all of the obligations of this Release on the child's behalf.

I AGREE that "Thunderbird Show Park" as used above includes all of their officials, officers, directors, employees, agents, personnel, volunteers and affiliated organizations.
